Aboriginal and Torres Strait Islanders' Education and Support Policy



Statement of Acknowledgement

1. Royal Greenhill Institute of Technology (RGIT) acknowledges the Traditional Owners of country throughout Australia and recognises their continuing connection to land, waters, and culture. We pay our respects to their Elders past, present and emerging.

Purpose

- 2. The purpose of this policy is to set out guidelines for ensuring, providing, and promoting non-discriminatory, inclusive practices and processes to provide equal opportunities for Aboriginal and Torres Strait Islander people.
- 3. In addition, this document aims to define the intentions of RGIT in relation to its commitment to Aboriginal and Torres Strait Islanders and reconciliation among all Australians. RGIT supports the concept of equal opportunity and is committed to providing all staff, students and prospective students with a working and learning environment which values diversity, respects differences and provides an environment that is safe, healthy, positive, supportive, and free from all forms of harassment, bullying or discrimination.

Scope

- 4. This policy supports the Australian Skills Quality Authority (ASQA) Standards for Registered Training Organisations 2015 and Australian Nursing and Midwifery Accreditation Council (ANMAC) requirements for leading to Nursing Registration. All staff and contractors employed or engaged by RGIT are obliged to comply with this policy.
- 5. The policy has been developed and implemented to support and provide clear instruction and guidance for Aboriginal and Torres Strait Islander students and RGIT staff about matters pertaining to Aboriginal and Torres Strait Islanders.
- 6. This policy relates to the provision of all training and support services offered to Aboriginal and Torres Strait Islanders and procedures and approaches that ensure that RGIT training programs are responsive to the diverse needs of all Aboriginal and Torres Strait Islander students and prospective students.

Policy Statement

- 7. This policy acknowledges that Australian Federal and State legislation make it unlawful for organisations to discriminate against individuals because of their age, gender, race, marital status, sexuality, or physical or intellectual disability. RGIT aims to deliver courses in a fair, open, transparent, and equitable manner, irrespective of age, disability, colour, race, gender, religion, sexuality, family responsibilities or location.
- 8. RGIT will work to establish itself as a site of exemplary practice in Aboriginal and Torres Strait Islanders' education and training.

Responsibility

9. The Academic Dean has overall responsibility for implementing this policy. Other responsibilities are outlined within the policy. The Academic Dean will review this policy annually, or in case of legislative changes requiring amendments.

Definitions

10. Aboriginal and Torres Strait Islander cultural competence and capabilities means student and staff knowledge and understanding of Aboriginal and Torres Strait Islanders' cultures, histories, contemporary realities and protocols, and proficiency to engage and work effectively in Aboriginal and Torres Strait Islanders' contexts and expectations (adapted from Universities

Australia, Guiding Principles for Developing Indigenous Cultural Competency in Australian Universities, October 2011).

- 11. **Aboriginal and Torres Strait Islander person** mean (as adopted by the Commonwealth of Australia for administrative purposes) any person who is of Aboriginal and/or Torres Strait Islander descent; identifies as an Aboriginal and/or Torres Strait Islander; and is accepted by the Aboriginal and Torres Strait Islander community in which they live as an Aboriginal and/or Torres Strait Islander.
- 12. **Aboriginal and Torres Strait Islanders' education** means educational opportunities and outcomes for Aboriginal and Torres Strait Islanders; and the opportunity for all Australians to gain knowledge about Aboriginal and Torres Strait Islander cultures, histories, contemporary realities, and protocols.
- 13. Aboriginal and Torres Strait Islander perspectives means Aboriginal and Torres Strait Islanders' worldviews, histories, cultures, law and lore, values, beliefs, languages, lifestyles, and roles.
- 14. Self-determination is the internationally recognised right of Indigenous peoples to control their own affairs, maintain their culture and heritage and determine their own future.
- 15. Student means any student admitted undertaking an RGIT course.
- 16. Student lifecycle means the recurring RGIT processes and experiences for individuals from prospective student, applicant, student, alumni, and parent of a future student.
- 17. Worldview means a set of beliefs and values that are honoured and held by several people.

Principles

- 18. The following principles underpin RGIT's approach to Aboriginal and Torres Strait Islanders' learning, teaching, and training:
 - 18.1 whole-of-institute and equitable approach across the student life-cycle
 - 18.2 Accountability of all executive and staff members of RGIT
 - 18.3 Embedding Aboriginal and Torres Strait Islander perspectives, knowledges and voices in all that we do;
 - 18.4 Self-determination for Aboriginal and Torres Strait Islander people
 - 18.5 Fostering an environment that is welcoming, respectful, culturally safe, non-discriminatory, and free of harassment for Aboriginal and Torres Strait Islander people
 - 18.6 Student retention, completion, growth and success at all levels of education and training.
 - 18.7 Recognition and valuing of traditional and contemporary histories, values, languages, culture and knowledge;
 - 18.8 Respect and civility among and between staff and students;
 - 18.9 Opportunities for engaging in the governance, decision making, planning, delivery and evaluation of education and training; and
 - 18.10 Proactive support of students and staff through co-creation, collaboration, consultation, and inclusion.

Guidelines

- 19. RGIT endeavours to provide an environment of support and care for Aboriginal and Torres Strait Islanders students that is conducive to cultural understanding and sensitivity.
- 20. Where a student identifies as an Aboriginal person and/or Torres Strait Islander during enrolment or orientation it is recorded in the Student Management System and notification made to the

relevant Course Coordinator. The Course Coordinator is responsible for ensuring that the student is offered the opportunity to contact the Academic Dean (who is a member of the Aboriginal and Torres Strait Islander Education and Support Committee) if that is their wish. It is the responsibility of the Course Coordinator to ensure that appropriate referrals are made.

Teaching and Assessment

21. All Aboriginal and Torres Strait Islander students are to be offered support to assist them to participate in the training and assessment activities. RGIT may provide support services, or arrangement for services, for Aboriginal and Torres Strait Islander students and prospective students. To ensure that all curriculum and training materials are inclusive of student needs, RGIT considers cultural and diversity and the needs of Aboriginal and Torres Strait Islander people.

Harassment and Victimisation

22. RGIT supports the rights of Aboriginal and Torres Strait Islander students and endeavours, wherever possible, to protect them from discrimination, harassment or victimisation.

Marketing

23. All RGIT marketing material is to include words to indicate that Aboriginal and Torres Strait Islanders are welcome to apply for all courses.

Recording

24. All documentation and records are to be filed on the students record in the RTO Manager Student Management System.
